

Directions to the State Attorney's Office West Palm Beach-Main Office

Handicapped Parking Directions for West Palm Beach

When taking the Okeechobee Blvd. exit, go east, and turn left at Tamarind Ave. Turn right on Banyan Blvd. Pass the 505 Banyan Blvd., jury parking garage. Cross the RR tracks (CSX tracks). Immediately after you cross the RR tracks, you will turn left at the traffic light on Quadrille. Turn right on 3rd Street.

Courtesy handicapped parking spaces are available on a first come first served basis on 3rd Street between Quadrille and Dixie Highway. The entrance is just west/behind the State Attorney's Office building. When going east on 3rd Street, the entrance is on the left. If you get to the traffic light at Dixie Highway, you have gone too far.

- From I-95 going north, exit at Okeechobee Blvd.
- Go east or right toward downtown West Palm Beach
- Turn left at first set of RR tracks (Tri-Rail tracks) on Tamarind/Parker. You will see the Kravis Center.
- Turn right on Banyan Blvd.
- From I-95 going south, exit at Palm Beach Lakes Blvd.
- Go east or left
- Turn right at traffic light on Australian Ave.
- Turn left on Banyan Blvd. at traffic light. WPTV NewsChannel 5 television station will be in front of you.
- Cross first set of RR tracks (Tri-Rail tracks)
- DIRECTIONS ARE THE SAME FROM THIS POINT ON
- Pass the federal courthouse on the right.
- Turn left at 505 Banyan Blvd., jury parking. Turn left before RR tracks (CSX tracks).

- Take ticket (an ivory color square card) and bring it with you to the State Attorney's Office. Volunteers will get their parking validated.
- Parking is not validated at any other parking garage.
- Park on the ground level or in the garage. If you park on level 4, there is a covered pedestrian bridge that takes you across North Quadrille and RR tracks.
- Once you exit your car, proceed east, crossing over the RR tracks, you will see the courthouse in front of you. Cross North Quadrille. Walk one block east toward Dixie Highway. Go to 3rd Street.
- On 3rd Street, stay on the north sidewalk (stay on the opposite side of the street from the courthouse). Pass the Public Defender's Office and U.S. mailbox and newspaper stands on your left.
- At the corner of 3rd Street and Dixie Highway, turn left/north. The entrance is on the left.
- Once you go through security, check in with the receptionist at the main desk. Present your ticket to the receptionist to be validated.
- For additional parking, there is metered parking on the street. There is no reimbursement for metered parking.
- Please allow 10 minutes to park your car and walk to the office.

**Directions to Belle Glade, Delray Beach, Gun Club and
Palm Beach Gardens Offices**

All offices are located in the courthouses of these respective cities. Each courthouse has a flat parking lot. In Delray Beach, there is additional parking on the street. There is no charge for parking.



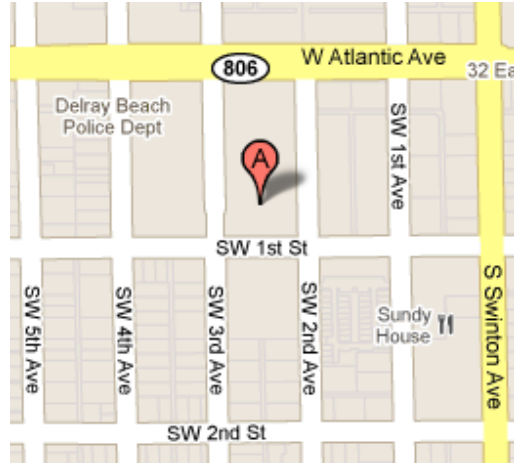

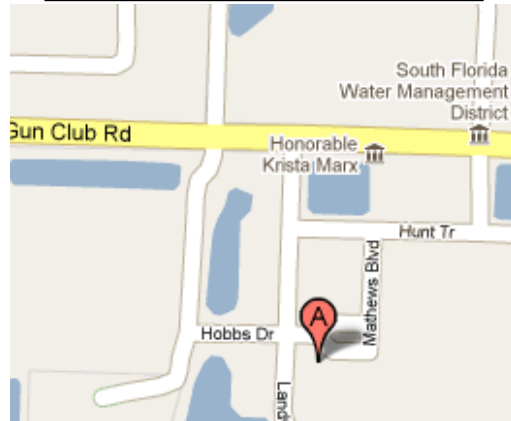

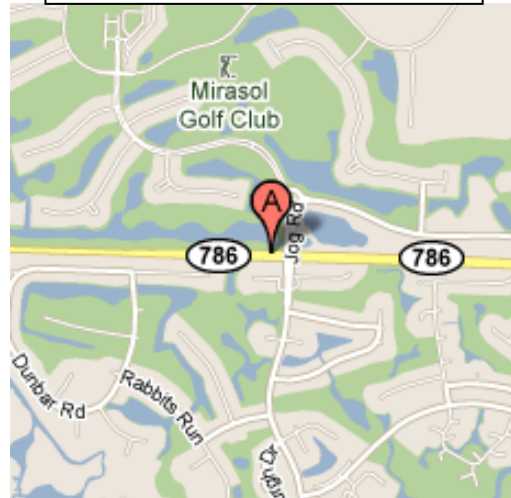
